Reports

City of Mississauga

Investigating licensing dog walkers and limits on numbers of dogs in City Parks and/or leash-free zones. They have looked at examples in Toronto and BC.

Andy Wickens - Discussed City's relationship with LFM as an affiliated group that runs itself, and makes policies. City will intervene if there are safety issues. Hazel assists LFM.

Hazel McColl - Looking at modifying timing and quality of grass cutting. Will consult with LFM on details.

Debra brought up that up the only unusual thing that happened in January was I recorded \$183 in donation from Apex Tools and \$183 in expenses non-cash transaction into the books for Toto. In response to a question regarding a donation item, Debra advised that the Vice President has received a donation.

Lynne noted that LFM's accounting procedures provide for funds being reserved for the use of a single park.

- Andy W. Suggested LFM prepare a proposal for park standards and maintenance esp. lighting and safety issues

Motion (Moved by Shane, seconded by Debra) That we strike a committee to develop a proposal for the management of Leash Free Zones that defines the relationship between LFM and the City. Carried

Jack Darling - Rotted Branch felled by City Severely ill elderly dog dumped in Zone in Fall Lakeside - cold and windy - need to adjust gates

Parkway Belt - attendance reduced by wind and cold - facebook page for zone developed

Quenippenon Meadows - Michael Wood reported problems with litter and poop - difficulties during the construction

Tottoredaca - wood chips issue - resolved at meeting in Zone by vote that chips will be spread at the discretion of the Zone Rep

- suggest looking into regulations regarding smoking in zones

Other Business

Policy Procedures and Constitution - Code of Conduct

The following items were approved in principle for inclusion in our Policies and Guidelines:

Code of Conduct

City Policy #05-01-10 - "Responding to Incidents in City Facilities" states on page 9 that:

"user groups and organizations are expected to take their own appropriate steps to address conduct by individuals or teams in accordance with the organization's own by-laws, regulations, and Community Service Codes of Conduct".

In keeping with this policy, the Leash-Free Mississauga Code of Conduct shall be as follows:

All Zone users SHALL:

act to promote the safety and peaceful enjoyment of the Zone

at all times watch and control every dog they bring into the Zone and carry a collar/harness and leash for each dog they bring to the park

close all gates behind them immediately and ensure that no gate is left open

pick up and dispose of their and their dog's litter in the garbage or recycling bins in the Zone including but not limited to poop, barf, clumps of animal hair, cups, cigarette butts, and

packaging.

treat each other with respect and not do anything to interfere with the peaceful enjoyment of the Zone

bring their own bags to the Zone for poop/waste pick up

take immediate action to prevent injury, bullying, or threatening by every dog they bring with them

All Zone Users SHALL NOT:

give any food, drink, or toys to any dog without permission of the dog's owner engage any dog in any activity without permission of the dog's owner
