- Minutes from January 5th 2022, Board Meeting Moved and seconded at 7:14pm that the minutes be approved.
- City of Mississauga Jamie Ferguson and Jenna Prokop:
 - Welcome to Jenna Prokop
 - moved from Recreation to Parks, Forestry and Environment
 - will be our main point of contact going forward
 - very familiar with Community Group Registry Program and some of the project grants that are available
 - Category Reviewer for Community Group Registry Program, will review our renewal recently submitted, will make recommendations to Jamie for final approval
 - Jamie will continue involvement supporting Jenna
 - Feedback from park users about ecoTraction
 - City started using ecoTraction, notified us in December, easier to use, sand was freezing, used leading up to gates
 - Garnetwood has used, love it, better on dog's feet, no complaints, better than sand, 2 big bags at each gate, combined with remaining sand, easier to spread
 - Lakeside recently delivered, much better than sand
 - Use up sand first
 - Lakeside fencing around swampy area has been completed beginning of January, looks great
 - Parkway Belt fencing near pool of muddy water will be done after thaw starts and contractors can get in, Jamie and Jenna can meet Carol on site
 - Parkway Belt willow tree trimming was completed by Forestry
 - Parkway Belt gaps in fence on west side were repaired
 - Quenippenon lights and water requests, Realty team and Region of Peel feedback still pending, Jamie will update Jenna to follow up
 - Woodchip outstanding requests on hold due to snow until spring when ground dries out a bit
 - Community Group Registry Program renewal in progress
 - Mississauga resident ratio a bit short of 80% target, but renewal recommended anyway
 - Current Jan.16/22 ratio number of members Mississauga to non-Mississauga is 798 to 240 total 1,038 members which is 76.9%
 - Member count increased by 69 from Oct.31/21 to Jan.16/22, ratio 63 and 6, percentage increased from 75.9% to 76.9%
 - 80% would be 960 to 240 total 1,200, difference of 162 Mississauga residents
 - Challenge is non-Mississauga residents are always welcome to join, so ratio always changing

- For every 1 non-Mississauga we need 4 Mississauga to maintain ratio
- Parks located on edges of Mississauga, so we always have non-Mississauga residents signing up
- Jamie will recommend approval, knows we are always working on Mississauga recruitment
- Park 459 at Churchill Meadows Community Centre will be constructed this year, hopefully opened in the fall, 5320 Ninth Line, south on Bus Station, should be parking
- Gate audits, checking hinges and latches working properly follow up
 - Staff were out early December to check gates
 - · Recent cold weather and thaw affected
 - Jamie asked general maintenance team to research and benchmark other leashfree parks across Canada to see what others use for gates and automatic hinges and latches to see if there is better options, anything a bit more robust, because ours seem to break down pretty quickly, maybe pay a bit more for equipment that will stand up to the use
- Quenippenon gates, gaps too wide follow up, and chicken wire fence
 - This work will be in the spring and summer
 - Originally requested by previous park rep Jill before Covid
 - City approval was obtained for:
 - ♦ Removal of fence down the middle in the first section
 - ♦ Move the gate to the pathway North
- Toto front parking lot construction, no updates yet from Peel Region
 - Toto notice board to back gate once this starts, please
- Paul Coffey, road signs with instructions how to get to leash-free park
 - See eparks.ca, Leash-free zone button, addition requested
 - Whole park will be upgraded phased approach over next 5-10 years, pathways will improve
- Wind shelters, Jenna will take on, to shepherd through, work with park planning and development teams, benchmarking others, not for humans to congregate, maintain visibility to watch dogs, any security risk
- Shed locks
 - Can do refresh of all locks for 2022, new codes would remain same for all parks
 - Garnetwood to be done soonest please with new 4 digit code
- Etobicoke Valley
 - Region of Peel project, update received 2 weeks ago
 - Park to be shut down for 18 months
 - Tree removals in March, 1 week closure, waiting for Forestry permit
 - April, May or June timeline for 18 months shut down
 - Jamie working on communication plan
 - Presentation to be made at next board meeting
 - There will be signage directing to eparks.ca for alternate parks
